



2020 Aloha Summer Regatta for the Harbor Heritage Perpetual Trophy

NOTICE OF RACE

August 15, 2020 at the Lido Isle Yacht Club
Organizing Authority: Fleet 1 of the Harbor 20 Class Association

1. GENERAL

- 1.1 The Aloha Summer Regatta is a fun, informal yet challenging race intended to give Harbor 20 sailors of all abilities the chance to compete together on a level playing field. The race will consist of a single random leg with start and finish in the waters off the Lido Isle Yacht Club (LIYC) main dock. Access to the LIYC facility will be limited as described herein. Decorate your boat and wear your favorite Hawaiian garb. No entry fee for Fleet 1 Members. Lunches (C'est Si Bon sandwiches) and beverages will be provided at no additional cost.
- 1.2 The OA may amend this NOR and the Sailing Instructions as necessary to comply with any laws, rules, regulations or guidelines from the Centers for Disease Control and Prevention (CDC), the State of California, Counties of Orange, other government agencies or US Sailing that are in effect during the event.

2. RULES

- 2.1 The race will utilize a "pursuit" or reverse handicap start. Individual start times will be determined based on the skipper and crew listed on the registration form. Any changes to registered skipper and/or crew must be communicated to the Race Committee before 1230 hours on Saturday, August 15.
- 2.2 The race will be governed by the rules as defined in the Racing Rules of Sailing and Harbor 20 Fleet 1 Bylaws.
- 2.3 The race is considered to be an "informal race" (see Fleet Bylaw Rule I.G.3).
- 2.4 Only the Skipper designated on the registration may helm the boat during the race, except for momentary relief in non-tactical situations.
- 2.5 RRS 44.1 and 44.2 will be changed so that only a One-Turn Penalty (one tack and one gybe) is required.

3. ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to all Harbor 20 boats.
- 3.2 Eligible boats must submit a completed registration form online at the Harbor 20 Class Association web site (www.Harbor20.org) no later than 1200 hours on Friday, August 14 or at the Lido Isle Yacht Club (LIYC) on Saturday, August 15 between 1200 and 1300 hours.
- 3.3 There is no registration fee for Harbor 20 Fleet 1 members. The registration fee for non-Harbor 20 Class Association members is \$20.00 per person.

4. LUNCHES

- 4.1 Complimentary lunches and beverages will be available. See registration form for details. Lunches and beverages will be distributed from the LIYC main dock and/or from RC support boats.

6. RACING

- 6.1 One race is scheduled.
- 6.2 The race will utilize a "pursuit" or reverse handicap start. Boats will start in groups of one or more at starting times to be determined by the Race Committee (RC). The individual starting times will be made available as an attachment to the Sailing Instructions and/or verbally no later than 1330 hours on August 15.
- 6.3 The race will start and finish in the harbor south of LIYC.
- 6.4 The course will be a random leg course. Course description will be displayed on the LIYC main dock prior to the first warning signal.

7. SCORING

- 7.1. The Low Point Scoring System in RRS Appendix A will apply, except that no scores will be excluded.

8. PRIZES

- 8.1. Prizes will be awarded after racing, from the LIYC main dock, to the top finishing boats, and best decorated boats and/or sailors.
- 8.2. The Harbor Heritage Perpetual Trophy will be awarded to the boat determined by the RC to be the winner.
- 8.3. Please stay after racing for the prize giving. Additional beverages will be available on the water from RC support boats after you finish the race and during the prize giving.

9. SAILING INSTRUCTIONS

- 9.1. Sailing Instructions will be available on line no later than at the LIYC on Saturday, August 15. Amendments to the Sailing Instructions may be made verbally by the RC no later than 1330 hours on August 15.

10. DISCLAIMER OF LIABILITY

- 10.1. Sailing is an activity that has an inherent risk of damage and injury. Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible or accept any liability for material damage to any boat or property, or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. By participating in this event, each competitor agrees to release the Harbor 20 Class Association, Fleet 1 of the Harbor 20 Class Association, Lido Isle Yacht Club, their past or present officers, directors, employees, representatives, agents, and race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law. This Disclaimer is in addition and supplemental to the mandatory additional WAIVER, RELEASE, HOLD HARMLESS AND AGREEMENT NOT TO SUE FOR COVID-19-RELATED DAMAGES, attached hereto and incorporated by reference.
- 10.2. WAIVER, RELEASE, HOLD HARMLESS, AND AGREEMENT NOT TO SUE FOR COVID-19-RELATED DAMAGES. In consideration for being allowed to participate in this regatta, competitors and each crew member shall execute a waiver, release, hold harmless and agreement not to sue, indemnifying Harbor 20 Class Association, Fleet 1 of the Harbor 20 Class Association, Lido Isle Yacht Club and their past or present officers, directors, employees, representatives, agents, and race organizers for any and all claims, actions, causes of action, losses, liabilities, damages, and obligations of any kind, whether known or unknown, at law or in equity or otherwise, that arise out of any possible exposure to COVID-19 that occurs as a result of competitors' presence at or use of the Lido Isle Yacht Club facilities, or participation in this regatta.

11. ADDITIONAL INFORMATION

- 11.1. No guests will be allowed inside the LIYC clubhouse, but guests will have access to the main dock and designated bathroom facilities.
- 11.2. In compliance with LIYC policy and the California state public health order, face coverings must be worn on land, in LIYC facilities and on docks.
- 11.3. Maintain a minimum 6-foot distance from other participants on land and on docks.
- 11.4. Competitors are encouraged to bring sanitizing wipes, gel, or washing material, and to sanitize hands and boats before and after racing
- 11.5. Competitors are encouraged to bring water bottles rather than using club drinking fountains onshore.
- 11.6. Use judgment when assisting another sailor with his/her boat, lines, or equipment; what used to be consideration can now be contamination.
