## **SCAVENGING INSTRUCTIONS**

August 27, 2023 at the Lido Isle Yacht Club Organizing Authority: Fleet 1 of the Harbor 20 Class Association

## **ELIGIBILITY AND ENTRY**

The Scavenger Hunt is open to all Harbor 20 boats. Registrants must be members in good standing with the Harbor 20 Class Association and registered for the Summer Party to be eligible to sail in this event.

Registration for the Summer Party and Regatta must be completed online at the Harbor 20 Class Association website (<u>www.Harbor20.org</u>). Attending the Summer Party does not require entry in the regatta.

The Summer Party registration fee is \$45 per person before August 23, 2023; \$60.00 per person after August 23, 2023. The Scavenger Hunt entry fee is included in the Summer Party registration fee.

## SCAVENGING RULES OF SAILING

Each skipper will receive riddles that are clues to specific locations around Newport Harbor. Each boat will score points by submitting the correct answer to a riddle by email to **jwhitney25@gmail.com** or by text to **(949) 945-8389**. Each submittal should be submitted separately and must include boat number, riddle number, the answer, and a picture that verifies that the answer was observed.

A boat may begin the scavenger hunt at any time after the pre-event judging portion of the event on the docks. All answers must be received by the Scavenging Committee before 1500 hours. This is not a race.

## SCORING

- 1 point for each correct answer to scavenger hunt riddles.
- 1 point or each adult race-day participant in each boat during the race, limit 6 (all participants must be breathing).
- 0.5 point for each child (under 14) race-day participant in each boat during the race, limit 3 (all participants must be breathing).
- 0.25 for each live animal race-day participant (all participants be live animals).
- 1.5 point for each race day participant of an "all-girl skipper and crew."
- 1 to 5 points for best themed boat.
- Tbd number of points for the best judges' bribe(s) (judge's discretion).
- 1 point for every \$50 check donation to the Legal Fund plus 1 extra point for who donates the most money. (Checks should be made payable to: Harbor20 Class Association, Inc. and delivered to Gary Thorne the day of the race.)
- 1 point for having signed up for the Fleet Championship prior to the Scavenger Hunt.
- 1 point for bringing someone on your boat who has never sailed.
- 1 point for bringing someone on your boat who has never attended the Fleet 1 Summer Party.

## PRIZES

Prizes will be awarded best dressed crew, best decorated boat, most family members on boat, and best decorated dog. The Harbor Heritage Perpetual Trophy will be awarded to the boat determined by the Scavenging Committee to be the winner.
